DUE TO THE ONGOING COVID-19 PANDEMIC AND LOS ANGELES COUNTY HEALTH DEPARTMENT MANDATES, ALL PERFORMANCES WERE CANCELLED. THE COMPANY INCURRED NON-RECOVERABLE CANCELLATION AND POSTPONEMENT COSTS WHICH WERE PARTIALLY OFFSET BY PAYROLL PROTECTION PROGRAM FUNDING.

THESE ACTIVITIES INCLUDE OUR "OFF GRAND" PROGRAM AND RECITALS FEATURING WORLD RENOWNED OPERA SINGERS. THE COMPANY HAD SCHEDULED NINE SUCH PERFORMANCES FOR THE FISCAL YEAR ENDED JUNE 30, 2021.
